Non ADAA members will be refunded by cheque not voucher. No refunds will be made on Handler Participation Fees after **31<sup>st</sup> March 2008**, other than the following exceptions.

- The death of an entered dog prior to or on 3<sup>rd</sup> May 2008. ADAA must be notified no later than 9<sup>th</sup> May 2008 and a full refund will apply.
- Non-participation due to a bitch coming into season or an injury to the handler or dog will be considered for full or partial refund if notification is received by 2<sup>nd</sup> May and proof of inability to participate by a Doctor or Veterinarian is received by 9<sup>th</sup> May 2008.
- Complete cancellation of the event due to circumstances beyond the control of ADAA.

Refund requests must be made in writing to the Dogmania Sub-Committee, P.O. Box 2212, Gailles, QLD 4300 prior to the above dates. The ADAA Board will ratify their decisions and despatch refunds (which may be full or partial) as soon as practicable after the event, taking into account the volunteer nature of ADAA.
